#### **2024 POLICY**

# RELATING TO THE MOORINGS WAITING LIST, ALLOCATION OF MOORINGS and GENERAL MOORING PRINCIPLES.

# 1 Principles relating to Waiting List

- (A) Any voting member may apply for a mooring by placing his name on the Waiting List ,specific to type of mooring required, with a deposit of £100, refundable from first years mooring fee, but forfeited if no mooring taken or if membership lapses.
- (B) The month and year should be recorded when a member joins the Waiting List and the type of Mooring applied for.
- (C) Mooring points will be allocated: -
  - 1) 1 point for every year of voting membership
  - 2) 1 point for every year on the Waiting List.
- (D) The Committee may take the service a member may give or may have given over a number of years into consideration.
- (E) Absent members may keep their points, but they will not be increased during their absent membership.
- (F) Existing mooring holders may apply for a different size mooring via The Waiting List with a deposit of £100.

### 2 Principles for Allocating Moorings

- (A) Moorings will be allocated to voting members, according to the number of mooring points, for their **exclusive** use.
- (B) Mooring points will be allocated: -
  - 1) 1 point for every year of voting membership plus
  - 2) 2 points for every year of mooring use.
- (C) The position of the allocated mooring will depend on:
  - 1) Length and draft of the vessel.
  - 2) Compatibility with adjacent vessels.
  - 3) Any exceptional amount of use of the boat on behalf of the Club.
  - 4) The number of mooring points accrued by the mooring holder.
  - 5) A Club sponsored One-Design Racing Boat will be given special status.

- (D) The priority for annual mooring allocation is: -
  - 1) Existing mooring holder.
  - 2) Those returning from Sabbatical year.
  - 3) One-year only mooring holders.
  - 4) Members from Waiting List in order of mooring points.

# 3 General Mooring Principles

- (A) Members may apply in writing to the Committee for a Sabbatical year of absence, any longer period will only be granted in exceptional circumstances
- (B) Mooring points accrued by members may be transferred in the following circumstances: -
  - 1) Death: Points will be transferred to spouse/partner but not to the next generation.
  - 2) Divorce/Separation of relationship: The Committee would expect the parties to allocate the mooring points themselves.
  - 3) Shared boats, only the specified mooring holder may accumulate points: in the event of the alteration of the shared arrangement the Committee would expect the parties agree the distribution of points. It is suggested that the non-mooring holders join the waiting list from the outset.
  - 4) A mooring holder may not sell his boat, acquire a minority share in another boat and continue to hold a mooring.
- (C) Anyone who rejoins the Club after giving up membership cannot count points previously accumulated before they resigned.
- (D) A member may only hold one mooring at a time, but may be able to rent a second mooring on a temporary basis without accruing points or rights of renewal
- (E) A member who participates in the Elite Dry Sailing Scheme will not be allocated an additional mooring whilst part of that scheme. Membership of the scheme will not entitle the member to acquire additional mooring points under Clause 2(B) 2.
- (F) Notwithstanding the above guidelines, the Committee reserves the right to take such action, which shall be in the best interests of the Club.
- (G)The Committee shall be aware of the overriding principle of being fair to Mooring Holders and those on the Waiting List.

### 4 Club Moorings

- (A) 12 Club Moorings on the Inner Trott are kept vacant for the Elite Dry Sail Scheme
- (B) 1 Mooring at the Southern end of the Outer Trott is a Visitors mooring.
- (C) The three mooring closest to the Clubhouse on the Middle and Outer Trott are allocated for the Storage of Club Committee Boats and other vessels.
