### Conditions of the HISC direct debit scheme

- Only membership subscriptions, mooring fees, winter layup (where applicable) can be paid by monthly direct debit.
- Boat fees can be paid by direct debit, these are taken as a lump sum in February each year.
- Direct debits are requested from your bank on the 1st of each month.
- Mandate forms need to be submitted no later than 1<sup>st</sup> December for the following year. Any forms submitted after this date will be returned unprocessed.
- If for any reason, relating to you and you bank, your direct debit payment fails you
  will be required to pay the outstanding amount due within 14 days of our
  notification to you that it has failed.
- One mandate form is required for each membership; therefore if you hold a Family or Adult Single membership and are paying for a Youth membership also you will need to submit two separate mandate forms.
- Change of details; if you have changed your bank details and are not sure your bank
  has passed on the new details to us; please submit a new mandate form to ensure
  that we have the correct details before the direct debit run starts.
